



INADMISSIBILITY DECISION

The Human Rights Review Panel ("the Panel"), sitting on 4 December 2025 with the following members present:

Having considered the aforementioned complaint, introduced pursuant to Council Joint Action 2008/124/CFSP of 4 February 2008, the EULEX Accountability Concept of 29 October 2009 on the establishment of the Human Rights Review Panel and the Rules of Procedure of the Panel as last amended on 6 July 2023,

Having deliberated through electronic means in accordance with Rule 13(3) of the Panel's Rules of Procedure, decides as follows:

I. PROCEEDINGS BEFORE THE PANEL

1. The complaint was submitted by post on 10 March 2025 and registered on 13 March 2025.
2. On 23 March, the Panel requested additional information from the complainant regarding the documents listed in the complaint, which were not attached, and any objections to making his name public, considering his request to keep his identity confidential in the proceedings related to a previous complaint submitted in 2014.

3. On 14 April, the complainant submitted the documents listed in the complaint and confirmed that he did not object to his name being made public during the current proceedings.

II. THE FACTS

4. The complainant alleges that a neuropsychiatrist has been exploiting his family for business purposes, using sophisticated cyber tools, since 1998-1999.
5. The complainant also alleges that the aforementioned neuropsychiatrist has damaged his family's property and subjected him to physical violence, in collusion with other individuals. He asserts that since 2001, the violence against him has been constant and has intensified over time.
6. The complainant asserts that he has repeatedly reported the neuropsychiatrist's conduct to the police; however, they have failed to take any action. He provided the Panel with the complaints submitted to the Basic Prosecutor's Office in Gjakova/Djakovica in 2016 and 2017, along with a request made in 2020 to the Basic Court in Gjakova/Djakovica for access to his case files.
7. The neuropsychiatrist in question is the same individual whose conduct was at the centre of the complaint submitted in 2014, which the Panel declared inadmissible.

III. COMPLAINT

8. The complainant requests that EULEX Kosovo ensure the proper functioning of the local police and that he is granted the same rights as the other inhabitants of his town.

IV. THE LAW

9. Before considering the complaint on its merits, the Panel must determine whether to admit the complaint, taking into account Rule 29(1) of the Rules of Procedure. This provision states that the Panel may declare a complaint inadmissible in summary proceedings, *inter alia*, if the complaint falls outside the Panel's jurisdiction.
10. According to Rule 25(1) of the Rules of Procedure, the Panel's jurisdiction is limited to complaints concerning alleged human rights violations by the Mission in the conduct of its executive mandate. The Mission's executive mandate is established in Article 3 of the EU Council Joint Action 2008/124/CFSP, as amended by the EU Council Decision (CFSP) 2018/856.
11. The Panel considers that the complainant does not demonstrate or argue that EULEX Kosovo has been involved in any acts allegedly committed against him, nor that the Mission bears any responsibility for the inaction of the local competent authorities.

12. The Panel finds that the allegations made by the complainant are not connected to the Mission's executive mandate. Decisions concerning the investigation and prosecution of cases fall entirely within the competence of the Kosovo authorities.

FOR THESE REASONS,

The Panel unanimously holds that it lacks the competence to examine the complaint, as it falls outside the scope of its jurisdiction within the meaning of Rules 25(1) and 29(1)(d) of its Rules of Procedure, and

DECLARE THE COMPLAINT INADMISSIBLE.
